15. Multidisciplinary / interdisciplinary

The institution is presently following the Choice Based Credit System (CBCS) methodology in its curricula as endorsed by the affiliating University and the state government. Consequently, introduction/preparedness for NEP 2020 affiliated institutions is not there as of now. Hence the offer of Multidisciplinary/Interdisciplinary courses is restricted to Ability Enhancement Compulsory Courses (AECC) which include environmental education and project works. The college also offers Language Core Courses (LCC) which inculcate value-added education.

16. Academic bank of credits (ABC):

The institution is yet to receive any guidelines from its affiliating university regarding ABC.

17. Skill development:

Since the college is yet to take up NEP 2020 and is presently following the CBCS mode, only those skill development courses are followed which feature in the CBCS curricula. The institution presently offers 15 Honours courses and 02 Programme courses and all of these courses have specific syllabi on Skill Enhancement Courses (SEC) which are taught to enhance the soft skills of the students. However, in this academic session, the institution encouraged students regarding training-based skill enhancement courses through its MoU with RICE, Berhampore which conducted 06 training sessions related to skill enhancement in relation to the job market. The institution hosted a webinar on Career in Technology in association with Sripat Singh College and Nagar College on the National Technology Day 2023 in which 123 students participated via meet.google.com/urt-dnra-kxo on 11.05.23. The key speakers in the

said event included Mr. B.V. Ravi Shankar, T.P.O, IIT Bombay & Mr. D. Bhaduri, IT Business Proliferation-Webel Technology Limited.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Presently there are no online courses related to the integration of Indian Knowledge System. However, the college caters to Indian language & culture through the CBCS system of education particularly in subjects like English, Bengali, History, Political Science & the like. Teaching is usually done using both English & vernacular except while teaching English Bengali Sanskrit & Arabic. All question papers are set both in English & vernacular. The college has Bengali & Sanskrit in Honours and Programme courses & Arabic is taught through programme course only. Various days and events of national & international importance are observed with aplomb in the college. Since NEP 2020 is yet to be introduced "specific good practices" in this regard are yet to be conceived and implemented.

19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

Outcome Based Education is yet to be implemented in the institution since NEP 2020 has not been introduced. The college is still following the CBCS mode of education which in its way does include Programme and Course Outcomes, all of which are uploaded in the institutional website.

20.Distance education/online education:

Presently no vocational courses are taught through ODL mode in the institution. However, the IQAC encourages extensive use of ICT in teaching and learning activities. Online teaching is done sporadically only when there is a dearth of teaching days and at such times use of ICT gains maximum prominence. The college however has ODL (affiliated to the University of Kalyani) in English, Bengali, Education, and History and Netaji Subhas Open University's Study Centre - T-03 from 02.01.23 including PG programmes in Bengali, English, History, Political Science, Public Administration, Mathematics, Library and Information Science (B. Lib and M. Lib).

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

The college is affiliated under the University of Kalyani and follows the curriculum under CBCS since 2018-19, as laid down in the University guidelines.

Curriculum Planning:

1. At the beginning of the academic session, the departments in the Academic sub-committee meeting lay emphasis on reaching a balance between the demands of first-generation and advanced learners. Completion of the syllabus is always prioritized. The syllabi to be taught are distributed among the faculty of all departments in departmental meetings. And the same is shared with the students through subject-based WhatsApp groups.

2. E-texts and study materials are provided by the teachers in class and/or WhatsApp groups of the students and uploaded in Moodle LMS

3. The use of ICT is hardly ever compromised in the teaching-learning process.

Implementation:

1. To ensure an effective two-way learning process, emphasis is laid on students' participation, webinars, extension lectures, etc.

2. Departmental meetings are conducted to review the academic status and also to seek feedback from students.

1.1.2 - The institution adheres to the academic calendar including for the conduct of Continuous Internal Evaluation (CIE)

At the beginning of every session, the academic calendar is prepared and posted on the website in consonance with the guidelines laid down by the affiliating university. The university/college provides tentative dates for the commencement of internal examinations and end-term evaluation-related details. IQAC and the departments conduct meetings to distribute workload related to the fulfillment of the objectives of the CBCS syllabus. After the completion of syllabi, the departments embark upon Continuous Internal Evaluation procedures. The CIE is prepared and conducted in accordance with the guidelines of the affiliating university and the same is communicated to the students through notifications on the college website and also through the Whatsapp groups of the students well in advance. In order to test the assimilation of course materials and also to encourage original critical thinking CIEs are practised through unit tests, project assignments coupled with short viva-voce.. Students are always informed regarding their scope of improvement.

1.3 - Curriculum Enrichment**1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum**

Working within the guidelines of the CBCS by the University of Kalyani, teachers and students interact to make the curriculum relevant to larger social life. Subjects relevant to professional ethics, gender, human values, environment, and sustainability include Bengali, English, Arabic, Sanskrit, Political Science, History, Philosophy, Economics and Environmental Science. Different departments of the college and NCC, NSS, Equal Opportunity Centre, and the Women's Cell sensitize the student community as well as the faculty regarding these areas. 07 invited talks/extension lectures have been organized not only to diversify the teaching-learning process but also to integrate various cross-cutting issues. For example on 12.04.23 a special lecture was

arranged to sensitize the students about the annihilation of caste and on 21.05.23 another invited talk dealt with "Death Penalty and Rape: A Critique." NSS organized a rally against child marriage on 10.11.22, a blood donation camp on 15.12.22, and observed International Women's Day on 08.03.23. In addition to these, the 38th Annual Conference of Paschimbanga Itihash Samsad was organized from 17.02.23 to 19.02.23 not only to explore the diverse ways of reading history and gender but also to instill human values with an expanse within and beyond the prescribed curriculum. Besides, the screening of films including 'Parama' directed by Aparna Sen and 'Utsav' directed by Girish Karnad explored the nuances of ethics, gender, and sustainability, all of which enhanced the texts prescribed in the curriculum. As is evident, such activities of the institution included within its ambit the curriculum of CBCS and the beyond, with equal emphasis.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

At the very outset of the academic year strategies are designed which would help the students and teachers in their teaching-learning and evaluation process. In an academic sub-committee meeting decisions are taken under the aegis of IQAC to form class-wise, subject-wise Whatsapp groups of students. The teachers orient the students regarding the teaching-learning and evaluation processes, attendance, Continuous Internal Evaluation (CIE), syllabus, and teacher-wise syllabus distribution details.

During class through interaction and CIEs, slow learners are identified. Since teachers are available in e-platforms including Whatsapp groups such learners are encouraged to interact to clear their doubts or to seek assistance regarding academic and administrative difficulties. Handouts are given in the class and also soft copies of e-texts are distributed to the students in their Whatsapp groups and stored in the Moodle LMS for ready access. Heeding to IQAC's suggestion, the Teacher-in-Charge issued a notice dated 03.08.2022 to take online classes beyond college hours particularly for the slow learners, though not strictly restricted to them exclusively. And the teachers acted likewise for the benefit of the students all through the session.

To make the class comprehensible even for the slow learners, PPTs are extensively used and the advanced learners are encouraged to participate in seminars/extension lectures/ invited talks and other extension and outreach activities. Some departments including English and Bengali also arrange film shows based on texts of the syllabi for the benefit of both the slow and the advanced learners.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

The college at the beginning of each session defines and explains the course objectives, programmes, and outcomes of the courses and their scopes. In this academic year, the same was done by the teachers through the orientation classes. Internal examination system through short class tests, dissertations, and methodology of undertaking projects. IQAC instructed the teachers to make their classes more interactive and student-centric. Audio-visual presentations are used to provide experiential and participative learning processes. Certain departments additionally conduct student seminars in online/offline modes. These methodologies greatly help the students in developing self-confidence. Intimations regarding CIEs are circulated well in advance through institutional websites as well as the students' Whatsapp groups. Corrected scripts are shown to the students to point out their areas of betterment. Extra academic queries if needed are escalated to the head of the department, IQAC, and the Teacher-in-Charge. All these measures enable the students to participate in the teaching-learning process with confidence and with a sense of belongingness.

2.3.2 - Teachers use ICT enabled tools for effective teaching-learning process. Write description in maximum of 200 words

The college follows ICT-enabled teaching in addition to the chalk-and-duster classroom education. The college has multiple classrooms with pre-installed audio-visual teaching gadgets to facilitate the use of ICT. There is a smart classroom that can accommodate 100 students in which outreach and extension activities are carried out. Since almost all the teachers have been provided with laptops and the institution offers free wi-fi to all, the use of ICT is a common practice among the teachers. In addition to extensive use of PPTs, the teachers use video clippings, audio lectures, and the like in their classes. Invited talks of experts are often recorded and either live streaming is done on YouTube or the video files are uploaded later on YouTube for ready reference at any point of time. Study materials and soft copies of handouts are uploaded in the Moodle Learning Management System of the college. There are 186 computers in the college to facilitate ICT in the teaching-learning process. The computer centre of the college can be used for all syllabi-oriented requirements and for extension activities.

2.5 - Evaluation Process and Reforms

2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

The college practices transparency and a robust evaluation process in terms of frequency and variety. The admission is provided purely on a merit basis and the admission list is made public along with students' scores at the 12th level. Regular and continuous evaluation is made both on the college and university levels. The college follows the academic calendar provided by the university to conduct end-term examinations. Internal evaluations are conducted by the college based on decisions arrived at academic and Examination sub-committees meetings in internal examinations. Question papers are set by respective subject teachers and the results are displayed regularly. Interactions with students regarding the syllabus of internal assessments, and marks distribution of the question papers are some of the mechanisms implemented by the college to maintain transparency in internal assessment. Corrected answer scripts are shown to the students so that they can identify their mistakes. From this session onwards, the IQAC has set up a grievance redressal mechanism for all students through the college's website. All these measures make the system of internal assessment robust in this institution.

2.5.2 - Mechanism to deal with internal examination related grievances is transparent, time- bound and efficient

The college has an Examination sub-committee which is responsible for internal examinations for the college. The students are

informed at the beginning of each semester regarding various components of the assessment procedures. The decisions of the examination sub-committee are intimated to the HODs who work accordingly to reduce any kind of confusion. The answer scripts are evaluated within the stipulated time by the respective subject teachers and if needed scrutinized by the HODs. This mechanism establishes a transparent method in which zero grievances occur. INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Jangipur College has a well-maintained campus of 10,000 sq.m. with basic compact facilities for students and teachers. Regarding learning resources, the college has a fully computerized library and reading room, a well-equipped computer centre, a smart classroom, 08 ICT-enabled classrooms, 09 laboratories, classrooms with green boards, a well-equipped conference room, and a hostel for boys. Support facilities include a teachers' staff room, a separate common room for boys and girls, and a subsidized canteen for students and staff. Both the girls' common room and the ladies' washroom have sanitary napkin vending machines and sanitary napkin incinerators. The college provides safe drinking water with water purifiers 10 aqua guards installed at various corridors of the campus along with 03 water coolers. The institution has a well-equipped gymnasium. There are two green generators, an open garage, and a parking space within the campus. The entire college is wi-fi enabled. The college also has a Day-Care Centre and a Students' Union Room. The college also has a four-storeyed Annexe Building of 621.37 sq.m. , 01 km away from the main campus in which ODL and Open University classes are held. The entire campus has 38 fire extinguishers (normal) and 02 (carbon dioxide extinguishers) to avoid accidents. The entire college has 14 CCTV cameras, a centralized display system, and the college is under surveillance 24x7. All these facilities taken together directly as well as indirectly facilitate the teaching-learning process offered by the institution.

Thereupon, the governing body of the college advances its recommendations to the teacher-in-charge. Work orders to vendors are thereafter issued. However, repair, purchase, or maintenance</p>									

works deserving urgent attention are immediately taken care of by the Teacher-in-Charge. Most of the electrical equipment used in the college is either under annual maintenance contracts or is periodically checked and maintained by competent technicians. Safety measures in the laboratories are strictly maintained in the science departments. The teachers along with the laboratory attendants keep records of the maintenance of the lab equipment and the institution ensures that all the equipment is calibrated. The maintenance of the library is entrusted to the librarian and the support staff. For maintenance of hardware/software authorized vendors are relied upon. The canteen sub-committee keeps a tab on the quality of food and hygiene of the canteen.

The institution has a pyramidal administrative structure with the GB at the apex comprising nominated members from the Government of West Bengal, affiliating University nominees, teacher-in-charge, representatives of the teaching community, and the non-teaching community. The teacher-in-charge is the academic and administrative head of the institution. At the strategic level, the teacher-in-charge, the governing body, IQAC, and various sub-committees engage in defining the policies and procedures, framing guidelines, rules, and regulations pertaining to academic and administrative development.

At the commencement of each session, the GB deliberates on academic, infrastructural, environmental, and student welfare policies keeping in view the analysis of the students' feedback done by IQAC and the recommendations of the various sub-committees. For example, the admission procedure is conducted strictly in accordance with the approved intake capacity and governmental policies of reservations. A complete schedule for online admission is displayed on the college website and the same is updated at every phase of admission in order to maintain fairness and transparency. The entire process of admission is handled by the admission sub-committee. The college also encourages the participation of the teachers in the decision-making bodies of the institution. The policies and methods of implementation as formulated by IQAC and subsequently ratified by the GB are implemented by the teachers and non-teaching staff throughout the session. There is also a Teacher's Council headed by an elected Teacher's Council Secretary who participates in academic and administrative procedures throughout the year.

1. Teaching faculty is appraised through the feedback which is

Best Practice 1

Title: 38th Annual Conference of West Bengal History Congress

Best Practice 2

Title: Death Penalty for Rape: A Critique (Invited Lecture by Sujato Bhadra, Human Rights Activist of International Repute)

Objective: To debate/discuss whether capital punishment is a necessary alleviation for Rape

Context: With 1 rape per 16 mins (2020) in India, with 96% rapists being known to the victim & with only 27.8 % being the conviction rate, debate over death penalty has gathered steam.

Practice: The talk (21.05.23) and interaction included 153 participants on meet.google/vei-ewtt-wjz & youtube.com/live/qF4r0KeF_Y8?features=share

Evidence of Success: Interactive session raised issues like dressing of victims, life-styles, culture etc. all of which made the event participative and discursive.
